Panels shall be secured along the male rib with approved clips and two (2) corrosion resistant #12-11 **Type A** fasteners of sufficient length to penetrate through the sheathing a minimum of  ${}^{3}/{}_{16}$ ". The panel clips were placed at a spacing listed in **Table A** below. The adjacent panel is placed over the secured panel/clip assembly and seamed with a double lock (180°) seam.


## LIMITATIONS
